013-2021 MEETING BY TELECONFERENCE

CONSIDERING the decree no. 177-2020 of March 13th2020 which declares the state of health emergency in the province of Quebec territory for an initial period of 10 days;

TO ASK the government authorities to increase the financial aid to the program PAFIRS or to set up a simular aid program with the same investment objectives and parameters, and that, to improve the standards of the different outdated infrastructures of sports and recreation.
